## REGULAR MEETING, 22 JUNE, 1983

The meeting was opened by President Carlos Amspoker.

The Treasurer's report was read and accepted.

Dick White presented us with \$2923 for sale of the Woody Pusher. It was moved, seconded and passed to put \$2923 in an interest bearing account.

There was a report by George Saunders and discussion on FAA licenses versus certificates. Per Mr. Saunders the FAA spends more time on violations than on prevention of accidents. He also reported on the Aviation Safety Report System run by NASA. With FAA accident forms you have ten days to file. The FAA won't talk to you until ten days after an accident. It is best to inform FAA, after an accident with one of these reports. Do not talk to the FAA; show them your certificate and medical card, and then clam up; get an attorney. Hearsay can be used; it's not a trial type deal. Do not show log books, "must present upon reasonable request". See FAR part 61.

"Call Back" is NASA's report on what the Safety Reports are saying. George Saunders left us with a Fact Sheet story on NASA Aviation Safety Report System.

A report on CAFE Raceindicated it was going good, better organized than ever before.

On the Open Auction there is one bid on each item so far. The auction for radio ends 1 July at 8 a.m., and the auction for AeroDuster ends 1 August at 8 a.m.

There was a report on Fly-Ins. There was no old business.

Information was received on a Seminar in Sunnyvale on practical aircraft design, using composite materials. Cost - \$95.00.
